INSTRUCTIONS

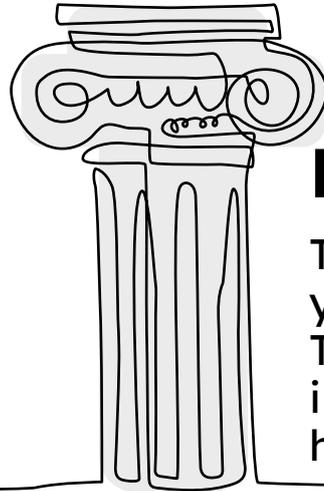
1. Audit Continuously: Make this a business habit. Did you close a deal? Navigate a crisis? Save time? Log the Operational Win immediately

2. Be Objective (The Jury Test): Stick to the data. If you were in court defending your value, what evidence would you show? Revenue generated? Hours saved? Client retention rates?

3. Consult Before Pitching: Never enter a high-stakes room (negotiation, pitch, board meeting) without reviewing this ledger. Anchor your nervous system in these facts.

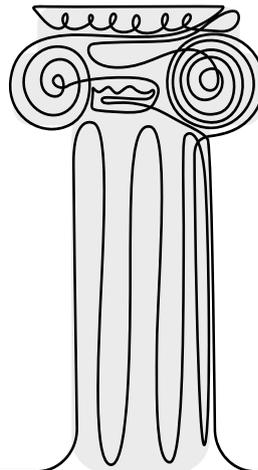
4. Track “Micro-Wins”: Systemic bias erases our daily competence. Documenting the small wins (e.g., “Sent the difficult email,” “Held the boundary on price”) is how you build Sovereignty.

PILLARS



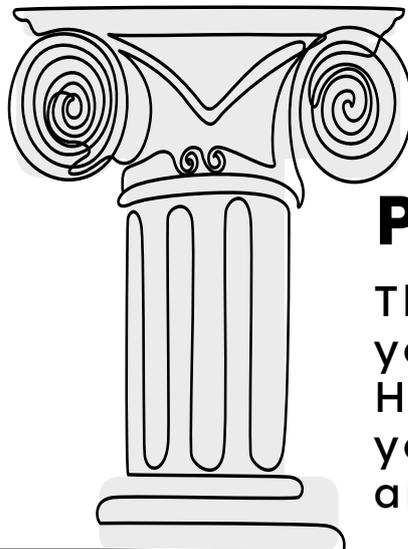
Pillar One

This is about your **achievements**. This is where you identify what you have accomplished



Pillar Two

This is about your **abilities**. This will involve listing your skills and strengths



Pillar Three

This is about your **accreditations**. Here you identify what you have learned and are qualified for

Concrete outcomes. Revenue generated, money saved, problems solved, or crises averted.

e.g. 'Delivered X Result', 'Managed X Budget, Provided X% ROI, 'Brokered X Stakeholder Relationship'.

TIPS FOR

GATHERING EVIDENCE

- 1. Save Emails:** File positive feedback immediately.
- 2. Request Specifics:** When someone says "Good job," ask "What specifically did you appreciate?"
- 3. Note Verbal Feedback:** Jot down positive comments from clients, suppliers, partners, or colleagues right after they happen
- 4. Track Your Progress:** Keep note of skills learned, modules passed, milestones reached.
- 5. Review Regularly:** Look back at old testimonials or references for evidence you might have missed.
